The Republic of Serbia / Republic Geodetic Authority has received financing from the World Bank toward the cost of the Real Estate Management Project, and intends to apply part of the proceeds for consulting services to skilled professionals, on a full time basis, for a one-year period as a members of the Implementation team of Integrated System of Real Estate Cadastre (ISREC). The following positions for IT system implementers for all IT activities that will be performed through the REMP Project in the RGA are open:

- ISREC IT Software implementer (2 positions); and
- ISREC IT Junior Software implementer (8 position).

The Consultants shall work as a team in order to support implementation of newly developed modules of ISREC (Phase I, Phase II and Phase III), provide first line support to end users in for all RGA offices (headquarters and branch offices as necessary) during the implementation of all IT systems, support debugging of software errors during Operational Acceptance testing phase, provide first line support diagnostic of software or infrastructure problems during daily activities of all RGA offices and reporting incidents to vendors or suppliers, participate in the installation of hardware and software for successful implementation of all project activities, participate in configuration and maintenance of hardware and software for successful implementation of all project related activities, provide customized statistical reports related to ISREC system on demand, and provide support to surveyors and lawyers in the process of data quality improvement.

The consultants shall be based in RGA headquarters and will travel to branch offices as necessary for completion of the above mentioned tasks.

The Republic Geodetic Authority now invites eligible individual consultants to indicate their interest in providing the Services. Interested Consultants should provide Cover Letter and CV demonstrating that they have the required qualifications and relevant experience to perform the Services.

The shortlisting criteria are:

For the position of *ISREC IT Software implementer*:

- University degree in Computer Science – IT;
- Minimum of 12 months of practical experience in developing/ administration of data models, developing/ administration of software applications and developing/ implementation of database; and

- Fluent English language – oral and written.

For the position of **ISREC IT Junior Software implementer:**

- Student of the Final year of study in Computer Science – IT;
- Area of interest: development/administration of data models, development/administration of software applications and development/implementation of databases; and
- Fluent English language – oral and written.

The following will be considered as an advantage:

1. Postgraduate studies in the stated area (only for ISREC IT Software implementer);
2. Graduate studies in the stated area (only for ISREC IT Junior Software implementer);

For both positions:

1. Experience in development and implementation of WEB based software applications;
2. Experience in developing spatial data models, developing and implementation of spatial database.
3. Experience in the area of ORACLE RDBMS and Programming and Java Programming.
4. Experience in deployment and maintenance of server virtualization environment
5. Experience in storage systems and backup solutions
6. Experience in establishment and deployment of WEB software platforms;
7. Experience in the area of ORACLE RDBMS and Administration.

In reference to the required knowledge and experience, the IT experts during the application process must provide adequate i.e. relevant documents (in scanned form or copies) proving that they possess the required working experience in the stated area.

The following selection criteria with corresponding points will be used for the above three positions in the evaluation procedure:

- Specific experience relevant to the assignment 50 pts
- Qualifications for the assignment 30 pts
- Competence for the assignment 20 pts

The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank’s “*Guidelines: Selection and Employment of Consultants under IBRD Loans and IDA Credits & Grants by World Bank Borrowers*”, published by the World Bank in January 2011 (“Consultant Guidelines”) and revised in July 2014, setting forth the World Bank’s policy on conflict of interest.
