

Праћењем решених предмета који су примљени у 2016 години просечан број радних дана за упис права својине над неопкретностима је 13,92. Просечан број дана за упис права својине над неопкретностима у првих 3 месеца 2017 године је 7,03 дана¹.

Циљ Републичког геодетског завода је да до 2020 године снизи просечан број радних дана за упис права својине над неопкретностима на испод четири. У овом тренутку се квартално прати колики је проценат решених предмета за мање од четири дана у односу на број решених предмета у периоду који се прати. Ово праћење се врши у свим службама Катастра непокретности Републичког геодетског завода. Проценте за Београд и Србију се раде као однос свих решених предмета у анализираним службама за мање од четири дана у односу на све решене предмете уписа права својине над непокретностима у анализираним службама.
