Assignment Title: Development of five year corporate strategy and 2-year business plan Reference No. SRB-REMP-8486YF- CQS-CS-16-034

The Republic of Serbia / Republic Geodetic Authority has received financing from the World Bank toward the cost of the Real Estate Management Project, and intends to apply part of the proceeds for consulting services.

The ultimate objective of the consultancy is to develop and present a clear and concise RGA Five-Year Corporate Strategy and 2-year Business Plan prepared with the involvement and active participation of RGA internal management and external stakeholders to ensure that the system is service-oriented and financially self-sustainable. The Corporate Strategy shall also include needs assessment for ICT development and proposed five-year plan for sustainable model of IT sector.

The products resulting from the work of the Consultant to be performed to deliver the five-year corporate strategy and 2-year Annual Business Plan include:

- Inception report including detailed work and action plan for the individual tasks to be completed;
- Institutional, legal and financial and ICT assessment report with relevant recommendations;
- Draft Corporate Strategy, based on three round table discussions conducted with RGA management;
- Draft five-year ICT development plan based on current needs assessment, technical and financial framework;
- Final five-year ICT development plan including recommendations on What, Who and How;
- Final Corporate Strategy based on three round table discussions conducted with RGA management and representatives from Ministry of Construction, Transport and Infrastructure, Ministry of Public Administration and local Self-Government and Ministry of Finance;
- Draft 2-year business plan (with all the content described in previous chapter) and its presentation to the RGA management;
- Final RGA Corporate Strategy and 2-year business plan, including institutional, ICT, legal and regulatory changes required for organization and business process reform. Round table discussion conducted with RGA management and representatives from Ministry of Construction, Transport and Infrastructure, Ministry of Public Administration and local Self-Government and Ministry of Finance with the objective of validation and acceptance of the Corporate Strategy and 2-year business plan.

The work will take place over six-month period.

The Consultant shall submit only one proposal, either individually or as a joint venture partner in another proposal. If a Consultant, including a joint venture partner, submits or participates in more than one proposal, all such proposals shall be disqualified. This does not, however, preclude a consulting firm to participate as a sub-consultant, or an individual to participate as a team member, in more than one proposal.
