REQUEST FOR EXPRESSIONS OF INTEREST CONSULTANCY SERVICES

Assignment Title: Python and Java Script Programming Language training Reference No. SRB-REMP-8486YF-CQS-CS-19-150

The Republic of Serbia / Republic Geodetic Authority (RGA) has received financing from the World Bank toward the cost of the Real Estate Management Project, and intends to the engage of Consultant firm to hold planned trainings:

• Python and Java Script Programming Language training.

The objective of the REMP is to improve the efficiency, transparency, accessibility and reliability of the Republic of Serbia's real property management systems.

RGA's annual Training plan for 2019 include specialist training for a defined number of RGA staff concerning training in programming languages Python and JavaScript. RGA staff should improve their knowledge concerning functional and aspect-oriented programming including metaprogramming and metaobjects with Python programming language. JavaScript programming language can run inside all modern web browsers and that is why selected personnel from RGA should be ready to use this programming language while maintaining RGA Web portal.

The consulting services ("the Services") include engagement of a Consultant firm ("Consultant") to hold the organize training courses as per fallowing specifications:

- Python Programming Language Basic and Advanced course.
- Java Script Programming Language Basic and Advanced course.

The Consultant will:

- Prepare detailed Training plan for providing services with specified schedule of trainings and training program in coordination with RGA;
- Prepare and organize pre-testing in order to estimate each participant's level of knowledge before start of training;
- Hold the training in accordance with the training plan and schedule agreed with the RGA;
- Obtain prior approval from RGA for any potential change of dates and training program;
- Prepare and organize post-testing upon completion training in order to estimate level of knowledge and new skills gained by each participant.

The first contracted course will start in January 2020 or later. Consultant services are expected to last until July 2020. The Consultant will hold the trainings in its own facilities (specially equipped for specific types of training), according to the previous agreement with RGA. Consultant will provide each attendant of the course with a computer enabling individual work.

The Consultant's training facilities will be in Belgrade.

The Project Implementation Unit (PIU) of the Republic Geodetic Authority now invites eligible consulting firms to indicate their interest in providing the above mentioned services. Interested consulting firms must provide information indicating that they are qualified to perform the services:

- experience and description of similar assignments
- availability of skilled staff
- CVs of key personnel that would be contracted for the assignment.

The shortlisting criteria are:

The Consultant firm is registered in the Republic of Serbia as a company specialized in computer training; Minimum two years of work experience in the above listed types of training; The Consultant will undertake the obligation of providing the data on the competence for provision of the required services in the form of brochures, description of similar services (references) and qualifications (CVs) of its teachers; The Consultant will provide Curriculum Vitae of proposed trainer/trainers detailing the most relevant experience related to this assignment.

The Consultant shall submit only one proposal, either individually or as a joint venture partner in another proposal. If a Consultant, including a joint venture partner, submits or participates in more than one proposal, all such proposals shall be disqualified. This does not, however, preclude a consulting firm to participate as a sub-consultant, or an individual to participate as a team member, in more than one proposal.

The following selection criteria with corresponding points will be used for the above three positions in the evaluation procedure:

_	Specific experience relevant to the assignment	50 pts
_	Qualifications for the assignment	30 pts
_	Competence for the assignment	20 pts

The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank's "Guidelines: Selection and Employment of Consultants under IBRD Loans and IDA Credits & Grants by World Bank Borrowers", published by the World Bank in January 2011 ("Consultant Guidelines"), setting forth the World Bank's policy on conflict of interest.

A Consultant will be selected in accordance with the CQS procedure set out in the "Guidelines: Selection and Employment of Consultants under IBRD Loans and IDA Credits & Grants by World Bank Borrowers", published by the World Bank in January 2011, revised in July 2014.
