Contract Title: Measuring altitude differences and leveling grid stabilization (South part of Serbia)

1. **The Republic of Serbia - Republic Geodetic Authority (RGA)** has received financing from the World Bank toward the cost of the **Real Estate Management Project**, and intends to apply part of the proceeds toward payments under the contract for: **Measuring altitude differences and leveling grid stabilization (South part of Serbia)**.

2. The **Project Implementation Unit (PIU) of Republic Geodetic Authority** now invites sealed bids from eligible bidders for performing activities on Measuring Altitude Differences and Leveling Grid Stabilization (South part of Serbia) in the area south of the line defined by cities Bajina Bašta – Čačak – Kruševac – Knjaževac, between the afore mentioned line to the north and state border with Bulgaria and Macedonia to the south. Approximate area to be covered is 17,250km². The works encompass stabilization of 581 points of Reference Levelling Network of Republic of Serbia and measurement of 663 altitude differences according to the measurement plan for this area with total levelling distance of approximately 3,400km counted one way only. Expected maximum time frame for undertaking the works is 30 months.

The Bidder shall furnish documentary evidence that it meets the following requirement(s):

- Minimum average annual (geodetic/surveying/construction works) turnover of 1,150,000 Euro, calculated as total certified payments received for contracts in progress and/or completed within the last 3 (three) years, divided by 3 (three) years;
- Experience under geodetic works contracts in the role of prime contractor, JV member, sub-contractor, or management contractor for at least the last 5 (five) years, starting 1st January, 2012.
- A minimum number of similar contracts specified below that have been satisfactorily and substantially completed as a prime contractor, joint venture member, management contractor or sub-contractor between 1st January, 2007 and application submission deadline: 5 (five) contracts, each of minimum value 150,000 Euro;
 - o For the above and any other contracts completed and under implementation as prime contractor, joint venture member, management contractor or sub-contractor on or after the first day of the calendar year during the period stipulated above, a minimum experience in the following key activities successfully completed: a) Stabilization of high precision geodetic network grids and b) Measuring of altitude differences for establishing high precision geodetic networks.
- The bidder must meet minimum legal requirements for performing geodetic works stipulated by Law on State Survey and Cadastre ("Official Gazette of Republic of Serbia", no. 72/2009, 18/2010, 65/2013, 15/2015 – decision of Constitutional Court and 96/2015), Article 17, Paragraph 2, and in accordance with Article 13 of the same Law.
- The Bidder must have at least five geodetic engineers with university level of education (graduated engineer of geodesy (level VII-1), Master Engineer of Geodesy (300 ESPB points) or equivalent).
- Joint Venture is allowed. Maximum number of members in the JV shall be three.

More details regarding qualification requirements are presented in the Bidding Documents.

3. Bidding will be conducted through the National Competitive Bidding procedures as specified in the World Bank's *Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers* issued in January 2011, revised in July 2014 ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.

4. A complete set of bidding documents in English language may be purchased by interested eligible bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of 100 EUR or equivalent in Serbian Dinars based on the selling exchange rate published by the National Bank of Serbia on the date of payment. The method of payment will be:
