Summary of Scope of Contract Awarded:

Requirements and objectives to be met and achieved by the consultants:

- Prepare data quality improvement procedure and solutions that includes: Define processes for data quality improvement for graphical and textual data based on current situation.
 - o Data quality improvement suggestions,
 - o Detail data error report containing list of corrections for textual and graphical data that should be resolved by authorized RGA staff, as well as:
 - a) topology checks of graphical data consistency;
 - b) incorrectly entered data in regards to the content;
 - c) data entered with correct content, but in not standardized format,

- which makes queries more difficult; and
- d) missing data, without influence on the validity of rights registered, but containing shortcomings, such as lacking personal number of citizen or address change not updated,
- e) to ensure the positional accuracy of the cadaster parcels
- Key performance indicators on the standardized manner in accordance with applicable legal regulations RGA that will allow RGA to monitor project progress and validate deliverables.
- o Integration database.
- Pilot project for 16 cadastral municipality- phase 1
- Proposals and recommendations for the simplest and easiest way to maintain accuracy and compliance of graphical and textual data of real estate cadastre as well as the manner of implementation of the changes arising in the process of maintaining the real estate cadastre, while maintaining data consistency.
- Propose and prepare integration procedure that will allow maintenance topological consistency of graphical and textual data for their transfer to official target Real Estate Data model, approved by the RGA.
 - In the past years, several activities and projects were executed in the RGA, where the current situation was analyzed and briefly described in section 4 general description. The consultant has an obligation to collect the results of previous analyses, integrate and finalize them, for the purpose of preparation integration procedure and for data quality improvement process.
- Execute knowledge transfer to the authorized RGA and/or external staff with aim that RGA can correct the errors and maintain the corrections during the first pilot phase of the contract and to proceed during the second phase.
- After the pilot phase, the Consultant shall create dynamics, timetable and schedule for cadastre municipalities that need to be controlled on a monthly basis, pursuant to the results from 16 controlled cadastre municipalities. For the implementation of the entire DQI process for all cadastral municipalities throughout the territory of the Republic of Serbia in the period estimated for this activity, the consultant shall propose a percentage of monthly performance.
- roll out for all cadastral municipalities in the Republic of Serbia phase 2 All deliverables must be in English and Serbian language
