- 1. The Republic of Serbia Republic Geodetic Authority (RGA) has received financing from the World Bank toward the cost of the Real Estate Management Project, and intends to apply part of the proceeds toward payments under the contract for: Construction works on Archive building.
- 2. The **Project Implementation Unit (PIU) of the Republic Geodetic Authority** now invites sealed bids from eligible bidders for performing construction works on new RGA's Archive building. The Archive is envisaged to be at the cadastral parcel no.98/27, Cadastral Municipality Zemun Polje, Municipality Zemun, address: line Ekonomija no.1. The parcel surface is 6,000.00m2, the building is planned to have a total gross area of 4,897.34 m² and will consist of one underground floor with 1,204.80m² gross area and three floors above ground with a total gross area of 3,692.54m² (B+Gf+2). The location of the new building is a part of the large business area stretching between housing estates Galenika and Batajnica. The expected period for the realization of the works is 12 months.

The Bidder shall furnish documentary evidence that it meets the following requirements:

- -The Bidder shall demonstrate that it has access to, or has available, liquid assets, unencumbered real assets, lines of credit, and other financial means (independent of any contractual advance payment) sufficient to meet the construction cash flow requirements estimated as **1,200,000 Eur** for the subject contract(s) net of the Bidders other commitments
- Minimum average annual (construction works) turnover of **6,000,000 Eur**, calculated as total certified payments received for contracts in progress and/or completed within the last 3 (three) years (2017,2018,2019), divided by 3 (three) years.
- Experience under civil works contracts in the role of prime contractor, JV member, sub-contractor, or management contractor for at least the last **10(ten)** years, starting 1st January, 2010.
- A minimum number of similar contracts specified below that have been satisfactorily and substantially completed as a prime contractor, joint venture member, management contractor or sub-contractor between 1st January, 2015 and application submission deadline:
 - The bidder must have completed successfully at least **2(two)** contracts of the similar nature and complexity, each of minimum value **3,000,000 Eur**. To prove this, bidder must submit original statements, signed by the client, with requested information.
 - The bidder must have completed successfully the contracts related to the construction of business-type buildings of minimum total **GBA 10,000m2**, and **1 (one)** of those buildings having **GBA 5,000 m2**. To prove this, bidder must submit original statements, signed by the client, with requested information.

Bidding will be conducted through the National Competitive Bidding (NCB) procedures as specified in the World Bank's <u>Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers</u> issued in January 2011, revised in July 2014 ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.
