- 1.2. During the past five (5) years, the Bidder must have completed at least (2) successful contracts for implementation or upgrade of Data Centre solution delivered and integrated in an existing IT infrastructure. To prove this, bidder must submit original statement, signed by the client, with requested information.
- 1.3. Manufacturer's Authorizations for Information Technologies except for those technologies which the Bidder itself manufactures are required for the following types/categories: Storage, Servers and Network equipment.
- 1.4. At least one (1) certified engineer for Information Technologies is required, for each of the following types/categories: Storage, Servers and Network equipment
- 1.5. The successful bidder must have the following support capabilities, during warranty period, or must demonstrate in the bid documentation a credible plan for establishing such capabilities by the contract signing:
 - Help-Desk telephone service with automatic problems application must be active 24 hours, every day.
 - For problems that cannot be resolved by telephone that are notified within 8:00am-8:00pm Monday through Sunday, qualified service personnel must be able to arrive on-site within 24 hours of problem escalation.

Lot 2

1.1. The minimum required annual average turnover over the previous five (5) years must be EURO 2,000,000.00 calculated at official exchange rate of National Bank of Serbia at the end of each respective year. To prove this, bidder must

submit balance sheets/audited financial statements certified by a registered accountant.

- 1.2. During the past five (5) years, the Bidder must have completed at least two (2) successful contracts for implementation at least three hundred (300) Desktop PC and NoteBook PC and one (1) successful contracts for security systems and one (1) successful contracts for Scale out NAS delivered and integrated in an existing IT infrastructure. To prove this, bidder must submit original statement, signed by the client, with requested information.
- 1.3. Manufacturer's Authorizations for Information Technologies except for those technologies which the Bidder itself manufactures are required for the following types/categories: Security Systems, Scale out NAS, Desktop PC and NoteBook PC.
- 1.4. At least one (1) certified engineer for Information Technologies is required, for each of the following types/categories: offered Security System and Scale out NAS.
- 1.5. The successful bidder must have the following support capabilities, during warranty period, or must demonstrate in the bid documentation a credible plan for establishing such capabilities by the contract signing:
 - Help-Desk telephone service with automatic problems application must be active 24 hours, every day.
 - For problems that cannot be resolved by telephone that are notified within 8:00am-8:00pm Monday through Sunday, qualified service personnel must be able to arrive on-site within 24 hours of problem escalation.

When submitting a bid for both lots, firms should meet the qualification requirements for each lot.

Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" (July 2016 Revised November 2017 and August 2018) ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.

The bidding document in English only may be purchased by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of EURO 100.00 or equivalent in Serbian Dinars (RSD) based on the selling exchange rate published by the National Bank of Serbia on the date of payment.
